Artist of the Month

For more than 40 years now, **Boi Sibug** has been capturing the essence of a typical world he grew up in with his paintings, portraits, designs and photographs, originally from Manila, Philippines, where he studied fine arts at the University of Santo Tomas, painted, worked in several major advertising agencies, and exhibited his works in more than 100 art shows. Sibug moved to the island of Guam in 1992 to accomplish more works described by art critics from Asia as "a collection of artistic gems."

While Sibug employs multiple media, his forte resides in oil, watercolor, pastel and charcoal. His talents do extend to creating graphic design and photographs, but his exceptional sense of colors and composition leads ultimately to a powerful rendering of images of beauty and order in the Pacific milieu.

Expectedly Sibug has been recognized through numerous awards for his works, and some of his paintings have become permanent features of galleries and lobbies of the finest places in Guam, Manila and USA. Boi is the 'Artist of the Year 2012 & Year 2013' of Torrance Artists Guild, California.

We are very pleased to announce that we are having an on-line virtual art show, **SVAA's Springtime Art Show 2021.** This show is for **members only**. There is no charge. If you are not a member and would like to enter this show, **you can become a member now!** It will be \$40 for individuals, \$60 for families, and \$20 for a student. Beginning on April 2nd each member is entitled to submit up to (3) three original art that has not received an award through an SVAA-sponsored art show and is recent artwork (nothing prior to 2017). Please send jpegs of your artwork along with your name, title, medium used, size and price of your art piece if you are selling to email svaaprints@gmail.com by Sunday, April 18th in order to have your artwork considered for the SVAA's Springtime Art Show 2021.

Our judge will be award-winning fine artist Dan Schultz. Dan will vote for the following awards across all artwork:

- Best of Show to be awarded \$250
- First Place to be awarded \$150
- Second Place to be awarded \$100
- Third Place to be awarded \$75

Honorable Mention(s) will receive ribbon(s). An artist will not be eligible to receive more than one award. After the voting period is completed, we'd like to host a **Zoom Awards Reception** to announce and recognize our award winners.
