ARTWORK SCREENING AND REVIEW:

IMPORTANT: All artwork will first be screened and reviewed by the SVAA Art Show Chairpersons at time of walk-in submission for eligibility, conditions, and proper artwork submission criteria as listed below. Non-compliance of these eligibility, conditions, and submission criteria may disqualify submission and entry of artwork.

ELIGIBILITY AND CONDITIONS:

- Open to all SVAA members current on dues.
- Artworks previously submitted at any SVAA Art Show without receiving an award are permissible.
- All artworks must be recent (2021 or later) and original work only, no reproductions.
- Entry form must be filled out, signed, and ready at time of walk-in submission. If you have any questions about the form, contact one of the SVAA Art Show Chairpersons.
- SVAA encourages but it is not mandatory that the artist include an artist statement for each artwork they submit. (See artwork statement form). Your statements will be added next to your artwork on display.
- All artists must declare their artwork in a selected category listed when filling out the entry form. The artist is responsible to make sure that the artwork clearly belongs in the selected category. If the artist is unsure what category to select for their artwork, contact the SVAA Art Show Chairpersons before completing the entry form.
- No Artificial Intelligence (AI) artwork is accepted for any category.
- Simi Valley Art Association reserves the right to photograph artist's artwork entered for the purpose of publicity.

ARTWORK SUBMISSION CRITERIA:

- Walk-in Submissions is on Saturday, February 21st from 11:00pm TO 1:00pm. Late entries will not be accepted.
- Maximum size of framed or unframed artwork can be no larger than 40" x 40" and no artwork shall weigh more than 40 pounds each.
- Artwork must be professionally finished, properly framed, and wired to hang. No saw-tooth hangers allowed. Sides of any gallery wrapped canvasses should be finished.
- Artwork must be family friendly. Artwork that shows nudity, political, religious, discriminatory, violent messages, or any other subject matter that is unsuitable may be rejected.
- Artwork must be picked up on Saturday, March 28th, 11am to 1pm. No early removal or arrangements are allowed.
